2 COMPOSITION/INFORMATION ON INGREDIENTS

Resin Base	: Silicon and Acrylic Copolymer Emulsion

3 HAZARDS IDENTIFICATION

Physical/Chemical Hazards	: This paint is NOT flammable
Human Health Hazards	: <i>Respiration</i> : May cause irritation. <i>Eyes</i> : May cause slight irritation. <i>Ingestion</i> : May cause gastro-intestinal irritation. <i>Skin</i> : In general no irritation

4 FIRST AID MEASURES

6 ACCIDENTAL RELEASE MEASURES

Personal Precautions	: Ventilate the area. Avoid breathing in vapours. Remove all sources of ignition e.g. flames, sparks, static electricity and heat.
Spill	: Contain and collect spillage with absorbent material. Dispose of according to local regulations. Do not allow spillage to enter sewerage drains or watercourses.

7 HANDLING AND STORAGE

- Handling** : Keep container tightly closed. Eating, drinking and smoking should be prohibited in area where this material is handled, stored and processed.
