## 2 COMPOSITION/INFORMATION ON INGREDIENTS

**Resin Base** : Acrylic resin emulsion

**Hazardous Components** : Acrylic resin and small amounts of organic solvents-this product is not classed as hazardous but should carry the following S Phrases S2, S24/25

## 3 HAZARDS IDENTIFICATION

**Physical/Chemical Hazards** : This paint is NOT flammable

**Human Health Hazards** :

- Respiration* : May cause irritation.
- Eyes* : May cause slight irritation.
- Ingestion* : May cause gastro-intestinal irritation.
- Skin* : In general no irritation

**Environmental Hazards** : Toxic to aquatic organisms. May cause long-term adverse effects in the aquatic environment.

## 4 FIRST AID MEASURES

**General** : In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.

**Inhalation** : Move to a safe area with fresh air. Keep person warm and at rest. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. Give nothing by mouth. **Eye Contact** : Rinse thoroughly with water for at least 10 minutes. Seek medical attention.

**Ingestion** : Do not induce vomiting. Keep person warm and at rest. Seek medical advice immediately and show the container or label.

**Skin Contact** : Remove contaminated clothing and shoes. Wash skin thoroughly with soap and water or use a recognized skin cleanser. Do not use solvents or thinners.

## 5 FIRE-FIGHTING MEASURES

This paint is NOT flammable but the dry residue is combustible Expect no direct explosion hazard Use CO2, dry powder or foam

## 6 ACCIDENTAL RELEASE MEASURES

**Personal Precautions** : Ventilate the area. Avoid breathing in vapours. Remove all sources of ignition e.g. flames, sparks, static electricity and heat.

**Spill** : Contain and collect spillage with absorbent material. Dispose of according to local regulations. Do not allow spillage to enter sewerage drains or watercourses.

## 7 HANDLING AND STORAGE

**Handling** : Keep container tightly closed. Eating, drinking and smoking should be prohibited in area where this material is handled, stored and processed. After handling the material, workers should wash hands and face before eating,

<b>Personal Protective Equipment</b>	:
