## 2 COMPOSITION/INFORMATION ON INGREDIENTS

<b>Resin Base</b>	: Acrylic Copolymer Emulsion

## 3 HAZARDS IDENTIFICATION

<b>Physical/Chemical Hazards</b>	: This paint is NOT flammable
<b>Human Health Hazards</b>	: <i>Respiration</i> : May cause irritation. <i>Eyes</i> : May cause slight irritation. <i>Ingestion</i> : May cause gastro-intestinal irritation. <i>Skin</i> : In general no irritation
