## 2 COMPOSITION/INFORMATION ON INGREDIENTS

**Resin Base** : Acrylic resin emulsion  
**Hazardous Components** : Acrylic resin and small amounts of organic solvents/Anti-Fungal additives this product is not classed as hazardous but should carry the following S Phrases  
 S2, S24/25

## 3 HAZARDS IDENTIFICATION

**Physical/Chemical Hazards** : This paint is NOT flammable  
**Human Health Hazards** : *Respiration* : May cause irritation.  
*Eyes* : May cause slight irritation.  
*Ingestion* : May cause gastro-intestinal irritation.  
*Skin* : In general no irritation  
**Environmental Hazards** : Toxic to aquatic organisms. May cause long-term adverse effects in the aquatic environment.

## 4 FIRST AID MEASURES

**General** : In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.  
**Inhalation** : Move to a safe area with fresh air. Keep person warm and at rest. ## 5 FIRE-FIGHTING MEASURES

## 6 ACCIDENTAL RELEASE MEASURES
